April 16 – Main Facility (All areas)

Orange County Corrections has partnered with Smart Communications to implement new digital communication options for the inmate population. Physical mail will be sent to an offsite location and electronically delivered. There will be a phased in approach of different components of the system. <u>Effective April 16, 2024, Inmates in all facilities</u> will be able communicate, via email messaging, and will also be able to receive photographs electronically. Processing of regular inmate mail will begin off site <u>April 19, 2024. Please see the "Sending Mail to Inmates" tab for more</u> information. Legal mail will continue to be to be mailed to the jail.

Please see information below on how to create an account.

1. Visit <u>www.smartinmate.com</u> to create your account. There is no cost to create an account. A photo ID will be required to create an account. Creating an account is fast and simple. You will be asked to create a username and password to identify your account along with some basic contact information. You will be sent an e-mail to verify and activate your account.

- 2. Once you have established the account, you will be able to search for inmates to connect with and send them a request. Inmate must approve the request before you can start communicating with them.
- 3. You must deposit funds in order to use the different communication options. You can purchase as many credits as you like and use them any time. You can also transfer credits to your contacts so they can easily respond to your messages.
- 4. A minimum \$5.00 deposit is required. There are two ways to add funds to the account:
  - a. You can do so online through your <u>www.smartinmate.com</u> account or;
  - b. You can send a money order to Smart Communications Deposit Center at P.O. Box 1848, Pinellas Park, FL 33780. You must ensure the Inmate's name and jail number are specified on the money order.
- 5. Current Costs for services are as follows:
  - a. Messages 50 cents each
  - b. Electronic Photographs \$1.00
- 6. Once you have purchased message credits, you can send and receive electronic messages and photographs. Electronic messages are delivered much more quickly than traditional paper mail to the correctional facility. However, you can continue to use regular physical mail as well as electronic messaging.
